## **YOUR OPTIONS TO ACQUIRE AURIS MINERALS LIMITED SHARES AT \$0.08 PER SHARE EXPIRE ON 20 SEPTEMBER 2017 (ASX:AUROA)**

We are writing to you as a registered holder of 20 September 2017 options in AURIS MINERALS LIMITED to remind you that the options will expire at 5:00pm (WST) on 20 September 2017.

Your option holding may be exercised in whole or in part by payment of \$0.08 for each option by no later than 20 September 2017. If payment is not received by 5:00pm (WST) on 20 September 2017 the options will lapse and all rights under the options will cease at that time.

Some of the courses of action available to you as a holder of these soon to expire options are:

- a) Exercise the options on or before 20 September 2017.
- b) Sell your options. Quotation of the options will cease at the close of trading on 14 September 2017.
