## **YOUR OPTIONS TO ACQUIRE AURIS MINERALS LIMITED SHARES AT \$0.12 PER SHARE EXPIRE ON 20 JUNE 2018**

We are writing to you as a registered holder of 20 June 2018 options in Auris Minerals Limited to remind you that the options will expire at 5:00pm (WST) on 20 June 2018.

Your option holding may be exercised in whole or in part by payment of \$0.12 for each option by no later than 20 June 2018. If payment is not received by 5:00pm (WST) on 20 June 2018 the options will lapse and all rights under the options will cease at that time.

Some of the courses of action available to you as a holder of these soon to expire options are:

- a) Exercise the options on or before 20 June 2018.
- b) Sell your options. Quotation of the options will cease at the close of trading on 14 June 2018.
- c) Do nothing (ie, allow your options to expire). If you do not exercise or sell your options they will expire on 20 June 2018 and your right to subscribe for ordinary shares in Auris Minerals Limited at \$0.12 per share will lapse.
