RNI NL (ASX: RNI) advises that it has allotted 125,000,000 fully paid ordinary shares (Shares) in total to sophisticated and institutional investors at \$0.012 per share to raise gross proceeds of \$1.5 million pursuant to the Placement previously announced on 30 September 2016.
